**ORDER GRANTING PLAINTIFFS'
UNOPPOSED MOTION FOR
PRELIMINARY APPROVAL OF
CLASS ACTION SETTLEMENT**

THIS MATTER having come before the Court on an unopposed motion for preliminary approval of a class action settlement filed by Plaintiffs Jamie Aguilar, Jessica Lobell, and Trever Palin ("Plaintiffs"), and Defendant Providence Health & Services – Oregon ("Defendant") supporting the motion and having entered into an arm's length settlement agreement with Plaintiff, and the Court being fully advised, now therefore;

IT IS HEREBY ORDERED THAT:

1. The settlement agreement filed with the Court is preliminarily approved as fair, reasonable, and adequate.
2. The proposed class is certified for settlement purposes only as follows: All hourly paid, non-exempt employees who were employed by Defendant in the State of Oregon at any time from July 8, 2022, through March 31, 2023.
3. The notice of settlement filed with the Court is to be mailed in substantially the same form to all members of the proposed class no later than 30 days after

entry of this order, with class members having at least 30 days from the mailing of the notice to opt out or object to the settlement.

4. Plaintiffs Jamie Aguilar, Jessica Lobell, and Trever Palin are appointed as class representatives and their service award is preliminarily approved.

5. Plaintiffs' counsel Bennett Hartman, LLP is appointed as class counsel and its attorney fees and costs are preliminarily approved.

6. A.B. Data, Ltd. is appointed as settlement administrator and its costs are preliminarily approved.

7. The final fairness hearing is set for 2-21-25, 2025, at 2:30 a.m./p.m.
